

## Waiver & Release of Liability Agreement

**Acknowledgment of Inherent Risks:** I acknowledge that participating in the EXACT Sport LLC (“EXACT”) athletic event is a significant test of physical and mental limits and carries potential risks including death, serious injury, and property loss. These risks include, but are not limited to, actions of other people (participants, volunteers, spectators, coaches, event officials), environmental factors (weather, natural conditions), and health risks (lack of hydration, COVID-19 exposure).

**Assumption of Risks and Release of Liability:** I voluntarily assume all aforementioned risks and accept sole responsibility for any injury, illness, or loss to myself or my child(ren), including personal injury, disability, death, and related liabilities, claims, or expenses. I hereby release, covenant not to sue, and hold harmless EXACT and its affiliates from any claims arising from these risks, including those due to their actions, omissions, or negligence.

**Participant’s Health Certification:** I certify that myself or the minor I represent are physically fit, have trained sufficiently for this event, received required immunizations, are free of contagious ailments, and have not been advised against participation by a medical professional.

**Insurance Responsibility for Domestic and International Events:** I understand and acknowledge that EXACT Sport LLC does not provide personal injury or health insurance for participants in its events, both within the United States and internationally. It is my responsibility to ensure that I have adequate personal injury and health insurance coverage, which specifically includes coverage for athletic participation, travel to and from the event location, and any other activities associated with the event, regardless of location. This insurance should adequately cover all potential medical costs and related expenses. I accept full responsibility for obtaining this insurance and for all costs related to medical care, treatment, or emergencies arising from my participation in EXACT events. I confirm that I accept the responsibility for any expenses incurred, whether covered by insurance or not.

### Additional Assumed Risks:

- **Travel-Related Risks:** I acknowledge and assume responsibility for risks associated with traveling to and from the event, as well as travel during the event itself, including accidents and delays.
- **Accommodation-Related Issues:** If applicable, I assume risks related to property damage, theft, or personal injury in accommodations arranged by EXACT.
- **Interpersonal Conflicts:** I acknowledge and assume responsibility for risks of conflicts or interactions with others, including the EXACT staff, participants, coaches, spectators and any others during the event.
- **Allergic Reactions and Dietary Needs:** I assume responsibility for any food-related incidents, including allergic reactions.
- **Equipment Malfunction Risks:** I recognize and assume risks associated with the use of sporting equipment, any items provided by EXACT as well as those provided by participants and spectators.

**Consent for Use of Likeness and Personal Information:** I consent to the use of our photographs, videos, or likenesses for legitimate purposes by EXACT and its partners. Common use of video, pictures and audio are for social media, website marketing, print materials and other promotional and networking activities. This consent includes sharing and using our email addresses, phone numbers, and other contact information for communication purposes, including marketing and promotional activities.

**Legal and General Acknowledgment:** This Waiver and Release of Liability will govern our actions and responsibilities during the event. We agree to release, indemnify, and hold harmless EXACT and associated entities from any liabilities resulting from our actions during the event. We consent to receive medical treatment as necessary during the event.

**Agreement Acknowledgement:** By continuing with registration, I affirm I have read, understood, and agree to all terms in this Waiver & Release of Liability, including additional risks and consent clauses. This agreement is intended to provide a comprehensive release and waiver under applicable law.
